## **Invitation to Negotiated Procurement**



### **Supply and Delivery of Audio-Visual Equipment for the College of Arts and Social Sciences**

1. Due to the two failed public biddings for the project Supply and Delivery of Audio-Visual Equipment for the College of Arts and Social Sciences, the Tarlac State University intends to procure the project by way of Negotiated Procurement, in accordance with Section 53.1 of the Revised Implementing Rules and Regulations of R. A. 9184.
2. The Approved Budget for the Contract (ABC) for the project Supply and Delivery of Audio-Visual Equipment for the College of Arts and Social Sciences is ₱ 1,930,000.00.
3. Delivery of the goods shall be within thirty (30) calendar days upon acceptance of the Notice to Proceed.
4. The Tarlac State University, through its Bids and Awards Committee now invites interested suppliers to the negotiations which shall be held on September 28, 2022 at 2:00 P. M. at the TSU Business Center AVR and via Zoom (Meeting ID: 826 1108 1791, Passcode: 917765).
5. Prospective suppliers must be Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to R.A. 5183.
6. Pursuant to Section IV (G) of the Guidelines in Annex H, a Certificate of PhilGEPS Registration (Platinum Membership) shall be a mandatory eligibility requirement for this procurement project.
7. The negotiations shall focus on the project requirements and guidelines, in accordance with the procedures prescribed in Annex H for Negotiated Procurement Due to Two Failed Biddings.
8. The deadline for the submission of the Quotations for the project shall be announced after the completion of the negotiations, and the final technical and financial requirements for the project shall be communicated to all suppliers who participated in the negotiations
