WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of Laboratory Equipment for DOST-TSU TBI-ASLAGAN with an Approved Budget for the Contract (ABC) of ₱ 2,409,000.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on August 3, 2023;

WHEREAS, in response to the Invitation to Bid, six (6) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) and webcasted via Zoom on August 11, 2023;

WHEREAS, in the public bidding held at the TSU-BC AVR on August 23, 2023, at 2:00 P.M.:

- (a) two bidders, namely, Diamond Industrial Systems Provider Inc., and Labtraders Inc., tendered a bid for the aforementioned project,
- (b) the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and evaluated the bid of Labtraders Inc. and found it to be substantially complying with the eligibility, technical, and financial requirements for the project as prescribed in the Bidding Documents and was rated "passed", while the first envelope of Diamond Industrial Systems Provider Inc. was rated "ineligible" on the ground that the submitted PhilGEPS certificate was valid but the Audited Financial Statement was not updated.
- (c) the BAC resolved to declare Labtraders Inc., as the bidder with the Single Calculated Bid with the amount of 2,350,000.00,
- (d) the BAC directed the TWGs to proceed with the Post-Qualification Evaluation of the and Single Calculated Bid;

WHEREAS, in the Post-Qualification Evaluation Conference held via Zoom on September 28, 2023:


- (a) the TWG for Financial and Legal Aspects reported that the Single Calculated Bid was responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents,
- (b) the TWG for Technical Aspect reported that the Single Calculated Bid was responsive to the technical requirements for the project as prescribed in the Bidding Documents,


- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to adopt the reports of the TWGs finding the Single Calculated Bid as responsive;


THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:


- (a) to declare Labtraders Inc. as the bidder with the Single Calculated and Responsive Bid (SCRB), with the bid price of Two Million Three Hundred Fifty Thousand Pesos (P 2,350,000.00), and
- (b) to recommend to the President the Award of Contract for the project, Supply and Delivery of Laboratory Equipment for DOST-TSU TBI-ASLAGAN to Labtraders Inc.



WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of Laboratory Equipment for DOST-TSU TBI-ASLAGAN with an Approved Budget for the Contract (ABC) of ₱ 2,409,000.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on August 3, 2023;

WHEREAS, in response to the Invitation to Bid, six (6) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) and webcasted via Zoom on August 11, 2023;

WHEREAS, in the public bidding held at the TSU-BC AVR on August 23, 2023, at 2:00 P.M., two (2) bidders, namely, Diamond Industrial Inc., and Labtraders Inc. and tendered a bid for the aforementioned project,

WHEREAS, the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and checked the first envelope contained in the bid submitted by the two bidders, using the non-discretionary "pass/fail" criterion, and found that the first envelope of Labtraders Inc. contained all the required documents and was rated "passed"; while the first envelope of Diamond Industrial Inc. was rated "ineligible" on the ground that the submitted Audited Financial Statement was not current and updated.

WHEREAS, the BAC with the assistance of the TWGs, then opened and checked the second envelope contained in the bid of the lone bidder and found that the second envelope contained the prescribed documents and was rated "passed";

WHEREAS, the BAC with the assistance of the TWGs, then evaluated the financial bid of the lone bidder with the result as summarized below:

THEREFORE, based on the foregoing findings, WE, the members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

(b) to direct the Technical Working Groups to proceed with the Post-Qualification Evaluation of the SCB and report their findings to the BAC within the prescribed period.


